

Terms and Conditions

Payment: All stall payments should be made within 7 days of receipt of your invoice. Your booking is not confirmed until we receive full payment.

First come, first served: Reservations and bookings are received strictly on a 'first come, first served' basis. Those whose booking fee is received first will be allocated the stall. Baby Dinosaurs reserve the right to decide the arrangement of stalls, and will only accept requests as to placement of stalls in exceptional circumstances.

Refusal of reservation: Baby Dinosaurs reserve the right to refuse acceptance of a reservation. This may be for a number of reasons, for example previous conduct by a stallholder, unsuitability of the type of business or craft stall being booked, or any other reason as given by Baby Dinosaurs.

Cancellation of stall booking: Sadly, bookings are NOT transferable or refundable.

Non-attendance: Stallholders who do not attend the market they paid for, will not receive a refund.

Market cancellation: Should Baby Dinosaurs cancel an event due to reasons of emergency, danger, weather conditions, disasters, health and safety, health concerns, or other reasons that are not within reasonable control of the organizers (as judged by Baby Dinosaurs), then stallholders will not receive a refund of their stall hire paid.

Health and Safety: Baby Dinosaurs are committed to providing, maintaining and promoting so far as is reasonably practicable, the highest standards of Health, Safety and Welfare at our events. Under Health & Safety legislation, stallholders are responsible for all activities that take place on their stall throughout the event, and any actions that could affect others because of their activity. Stallholders who do not adhere to these guidelines may be asked to leave the event.

Respecting the Venue: Stallholders must not cause any damage, or make any changes to the venues in which the Baby Dinosaurs are held. Do not hang, stick, tape, glue, nail, screw or in any other way affix items to any wall, door, floor, curtain or any other part of the building.

Damage and theft: Baby Dinosaurs accept no liability for the theft, loss or damage of any items from stallholder's stalls, of personal items, or other items within the boundaries of the event. All persons who enter the market area do so at their own risk.

Security: Stallholders are responsible for their own stall security and monies.

Liability: The stallholder agrees to indemnify Baby Dinosaurs against all claims for damages or injury to the property or person of any persons in respect of any claim by any such person arising out of negligence on the part of the stallholder or his agents or servants.

Promotional materials: Promotional materials available at stalls may only relate to the product/service on sale at that stall. Stallholders and their representatives are at no time permitted to distribute advertising or promotional material beyond their stall area (i.e. walking around the venue and handing out flyers, putting flyers on cars etc). A breach of this condition will result in the stallholder being requested to leave the venue.

Rubbish: It is the stallholder's responsibility to take unsold items with them. Please take all rubbish with you and leave your stall area the way you found it. Baby Dinosaurs reserve the right to dispose of any items left behind following an event.

Secondhand stallholders can sell: Quality second-hand goods relating to maternity, babies, toddlers, and children.

Business and craft sellers can sell or promote: New or hand crafted items relating to maternity, babies, toddlers, and children, services related to maternity and young families. Baby Dinosaurs reserve the right to decide whether a business or craft stall is suitable for attendance.

Secondhand sellers for Charity: may only sell secondhand items. Stallholders may distribute leaflets or information regarding the charity from the stall. Stallholders are not permitted to collect money on behalf of the charity in any other way than the sale of secondhand goods or a static collection box on the stall. No raffles or games will be permitted. Stallholders are entirely responsible for all monies reaching the charity.

Stallholders cannot sell: Items or services unrelated to maternity, babies or young children, or items which are deemed to be broken, in poor condition, dangerous, in breach of Health and Safety legislation or trading standards advice. Baby Dinosaurs reserve the right to request that items are removed from sale if it is felt they do not adhere to our guidelines and standards.

Transactions: Baby Dinosaurs accept no responsibility for any transaction entered into in the market enclosure.

Disagreements: Baby Dinosaurs reserve the right to decide or arbitrate any dispute arising out of, or during the conduct of the market.

Refusal of Admission: Baby Dinosaurs reserve the right to refuse admission to the market to any person without giving any reason for the same and to eject or cause to be ejected any person and /or his/her goods and chattels without giving any reason for the same.

Illegal Activity: Baby Dinosaurs shall not be held responsible for the noncompliance by a stallholder with any Law, By-law, Regulation, Act or Statute.
